REGISTRATION OF SUPPLIERS TO SUPPLY PROVISIONAL RATION ITEMS YEAR 2019

- 1. Applications for registration of suppliers to supply of provisional Items for the year 2019, can be downloaded through the web sites of Lanka Sathosa Ltd (www.lankasathosa.lk) from 30th November 2018 to 31st December 2018, free of charge or collect from the Procurement Division at 3rd Floor of under mentioned address by paying Rs.2,500/=.
- 2. Applicants are requested to furnish accurate information. If any information given is found to be inaccurate or any vital information is found withheld, the applicant will be disqualified for registration. An incomplete or illegible application will also be rejected.
- 3. Supporting documents should be attached to the application. Such documents should be serially numbered. The total number of pages should be indicated on the top right-hand corner of the main application.

3.1 Following documents should be attached with the application.

- a. Suppliers/Institutions who are seeking registration should provide certified copies of under mentioned legal documents (along with other documents) with the application.
 - Limited Liability Companies Company Registration.

 - Legal Right to Supply the Goods (Signatory of the Business is certified by an Attorney at Law)
 - Details of experiences involve in similar nature businesses.
 - Details of availability of Ware Houses and Transport.
- b. In the case of a supplier or his principal is not the manufacturer, the manufacturer should issue a letter of authority to the effect that the supplier or his principal is an authorized dealer or distributor.
- c. Cash Deposit Slip issued for payment of Registration Fee.
- 4. Duly completed Application Forms together with all the necessary documents should be hand delivered to the Procurement Davison at 3rd Floor at under mentioned address to reach on or before 31st December 2018.

- 12. Suppliers who are in the national list of defaulting contractors in terms of the clause number 8.11.5.C of the Government Procurement Guidelines 2006 (Goods & Works) are NOT PERMITTED to apply for registration.
- 13. Supplier should hold stock on behalf of the Purchaser as required and all suppliers will agree automatically to provide at least 15 days credit facility when they register under Lanka Sathosa Ltd for Supply of Provisional Ration Items.
- 14. Sealed Bids/Quotations will normally be called weekly or as per the requirement from the registered suppliers under Competitive Bidding method, in accordance of the Government Procurement Guidelines. However, the Lanka Sathosa Ltd reserves the right to call Bids/Quotations from a short-listed supplier or from any other supplier, when it is necessary.

- 15.
